Following are the minutes of the Residential Real Estate Council Regional Vice Presidents Committee Meeting held Tuesday, November 14, 2023, Hyatt Regency Orange County, Anaheim, CA

CALL TO ORDER:

The meeting was called to order at 2:40 pm by Kim Barnthouse, CRS (Chair Mark Shepherd, CRS was not in attendance).

OPENING REMARKS

Kim Barnthouse welcomed the Committee members and thanked them for all their hard work.

APPROVAL OF MINUTES:

The minutes of the meeting held May 6, 2023, were approved by consensus.

2023 IN REVIEW: SUCCESSES AND LESSONS LEARNED

The Regional Vice Presidents presented their annual reports, highlighting the achievements and challenges faced by their state leadership teams. Key successes included accounts of events organized, along with collaborative efforts with various organizations to either host or engage in these events.

The conversation also emphasized the critical role of effective communication within the leadership teams and the strategies for conflict resolution. An observation was made

regarding the correlation between recruitment challenges and the effectiveness of the leadership teams in the same state networks.

TRANSITION PLAN

The Committee discussed the importance of smoothly transitioning new leaders into their roles. Several RVPs highlighted that their states had introduced a Vice President position within their leadership teams. This addition allows the incoming President to shadow the current President, thus preparing better for their upcoming term.

Committee members expressed concerns over some states' ongoing difficulties in identifying and recruiting volunteers, noting that this issue complicates the leadership transition process. To address this, a suggestion was made to organize meetings tailored to states' sizes, providing a platform for sharing successful strategies and addressing common challenges in leadership transitions and volunteer recruitment.

EXECUTIVE SESSION

The Regional Vice Presidents proposed the need for receiving consistent updates regarding the progress and resolutions made by the Presidential Advisory Groups (PAGs), including actions taken by the Board of Directors. This recommendation stems from a concern expressed by some RVPs to prevent both themselves and state leadership from being taken by surprise by unforeseen decisions or changes.

ADJOURNMENT

There being no further business, the meeting was adjourned at 2:45 PM.
